- (3C) A natural person must not contravene, or fail to comply with, a direction issued under subsection (3B), including a requirement included in the direction under subsection (3D).

Penalty: Fine not less than \$5 000
and not more than \$10 000.

- (3D) A direction issued under this section to a person may include a requirement that the person must not, in the period of 3 months after the date on which the direction is issued –
- (a) commit an offence against a provision of this Act; or
 - (b) except in the case of a direction issued under subsection (3B), contravene section 6(1), (2) or (3).
